APPEALS SELF HELP CLINIC 2020 REPORT

In 2020 the clinic assisted 125 people. Due to COVID-19, the clinic was changed to phone only in March, but a clinic was held every month in 2020. 90% of the customers were seeking an appeal to the Court of Appeals. Last year 25% of all appeals to the Court of Appeals involved at least one unrepresented party. In family law cases, the number was 41%. Detailed data are listed below.
